HISTORY OF BCPL RAILWAY INFRASTRUCTURE LTD.

In the year 1984, Mr Aparesh Nandi, Mr Jayanta Kumar Ghosh, Mr Uday Narayan Singh and Mr Kanhai Singh the promoter Directors of BCPL started its operations.

The company started with a nominal capital of Rs. 50,000/- and a manpower of just 5 persons and has grown to its present net worth of over Rs. 80 crores.

They began as civil contractors for the Indian Railways.

In the mid 90s, BCPL ventured into Railway Electrification work which was gradually gaining importance in Indian Railways.

Soon the Company achieved a niche in the market for this specialized scope of work.

BCPL values its experienced staff strength that has promoted the growth of the organization.

Focus on Larger Railway OHE Projects



The company has decided to lay stress on larger Railway Electrification projects but with continued focus on the small and mid sized ones. The company has decided to adopt this strategy keeping in view the country's over dependence on imported petroleum products for its transport fuels. If this has to be corrected, the government and the private sector have to develop and expand the electrified transport routes, especially the Railways.



Focus on Power Transmission Lines



The management has decided to gradually enter into the power transmission infrastructure business. This would require the company to get work of the Power Grid Corporation and other entities in the National Power Grid network. This sector also has a vast growth potential as a large part of the country is still not served by electric power and also keeping in view the vast power generation capacities which are coming up through out the length and breadth of the country.
